RAFFIC SAFETY WARNING SIGNS IN VOCATIONAL SCHOOLS

ABSTRACT

Road traffic is a factor of every person's health. Ignorance of traffic rules is the cause of big problems not only among minors, but also among adults. this article describes the rules of conduct that should be followed by each warning sign. Warning signs inform drivers that they are approaching a dangerous road section and require them to take appropriate action depending on the conditions.

- 1.1. "Railroad crossing with a barrier".
- 1.2. "Railroad crossing without barrier".
- 1.3. "Caution, railway crossing blocking device". This road sign is installed before reaching a railway crossing equipped with a barrier device and warns drivers of vehicles that there is a barrier device ahead.
- 1.3.1. "Single track railway".
- 1.3.2. "Multi-track railway".
- 1.3.1. single-track railway, 1.3.2. railway signs with two or more tracks are installed in front of a railway crossing that is not equipped with a barrier.
- 1.4.1-1.4.6. "Approaching the railroad crossing."

Gives an additional warning about approaching a railroad crossing outside of populated areas.

- 1.5. "Intersection with a tramway".
- 1.6. "Crossroads of Equal Importance".
- 1.7. "Intersection with circular motion".
- 1.8. "The traffic light regulates." Traffic means an intersection, crosswalk, or section of road regulated by a traffic light.
- 1.9. "Lifting bridge". A drawbridge or crossing on the left.
- 1.10. "Going to the beach". It means going to the bank of a river or body of water.
- 1.11.1, 1.11.2. "Dangerous turn". 1.11.1 to the right, 1.11.2 to the left road signs indicate a turning point of the road with a small radius or limited visibility.
- 1.12.1, 1.12.2. "Dangerous turns". Road signs 1.12.1 first turn to the right, 1.12.2 first turn to the left indicate the part of the road with dangerous turns.
- 1.13. "Steep slope".
- 1.14. "Vertical height".
- 1.15. "Slippery road". Indicates a very slippery part of the road.
- 1.16. "Uneven road". The carriageway means the part of the road that is uneven (bumps, potholes, uneven connection of the bridge to the road, etc.).
- 1.17. "Danger of rockfall". Refers to a section of the road where there is a possibility of gravel, stones, etc. flying out from under the wheels of the vehicle.
- 1.18.1-1.18.3. "Narrowing of the road". 1.18.1 double narrowing; 1.18.2 means taper to the right and 1.18.3 means taper to the left.
- 1.19. "Two-way movement". Indicates the beginning of the oncoming traffic section of the road (carriageway).

- 1.20. "Pedestrian crossing". 5.16.1, 5.16.2 marks and (or) 1.14.1 1.14.3 indicates a pedestrian crossing.
- 1.21. "Children". Indicates the possibility of children leaving the roadway near a children's facility (schools, children's recreation centers, etc.).
- 1.22. "Intersection with a bicycle path".
- 1.23. "Repair works".
- 1.24. "Drive cattle."
- 1.25. "Wild animals".
- 1.26. "Stones fall". Rock refers to a section of road that can be moved, pushed and dropped.
- 1.27. "Side wind".
- 1.28. "Low flying planes".
- 1.29. "Tunnel". A tunnel that is not artificially lit or has a limited view of the entrance gate.
- 1.30. "Other risks". Denotes a section of the road with dangers not covered by warning signs.
- 1.31. "Artificial road unevenness". Warns about approaching a part of the road where an artificial unevenness has been installed. It is used to forcefully reduce the speed of the vehicle.
- 1.31.1, 1.31.2. "Direction of turning". Indicates the direction of travel on a road with a small radius and limited visibility, and the direction of bypassing the part of the road under repair.
- 1.31.3. "Direction of turning". T-shaped indicates the direction of movement at the intersection or road junctions, the direction of bypassing the part of the road under repair.
- 1.32. "Traffic". This road sign is installed in a place where it is possible to go around the road or intersection before entering the road or intersection with traffic in the case of a temporary or changing image.

Warning signs 1.1, 1.2, 1.5 - 1.32 are installed 50 - 100 meters before the dangerous place in the settlements, and 150 - 300 meters outside the settlements. If necessary, these signs can be installed at a different distance, as indicated in the additional information sign 7.1.1.

If the slope and height are consecutive, the symbols 1.13 and 1.14 can be placed directly before the slope and height. Outside the settlements, signs 1.1, 1.2, 1.9, 1.10, 1.21 and 1.23 are repeated. The second sign is installed at least 50 meters before the beginning of the dangerous part of the road. If short-term road works are being carried out in the traffic section, the sign 1.23 can be installed 10-15 meters away from the place of work (without additional information sign 7.1.1). Signs 1.3, 1.3.1 and 1.3.2 are installed directly in front of railway crossings, at a distance of not less than 20 meters from the nearest rail.

2. Marks of privilege

Privilege signs - determine the order of movement at intersections, intersections, and narrow sections of the road.2.1. "The main road". Traffic gives the right of way at unregulated intersections. The sign is installed at the beginning of the main road and directly in front of the intersections. The sign is installed at the beginning of the main road and directly in front of the intersections.

- 2.2. "The end of the main road".
- 2.3.1. "Intersection with a secondary road".
- 2.3.2, 2.3.3. "Secondary connection". 2.3.2 connection from the right, 2.3.3 connection from the left. 2.3.1 2.3.3 road signs are installed in populated areas at a distance of 50 100 meters from the intersection, and outside of populated areas at a distance of 150 300 meters.

- 2.4. "Give way!" The driver must give way to the vehicle moving from the crossing road, and from the main road when there is an additional information sign 7.13.
- 2.5. "It is forbidden to move without stopping." It is prohibited to move without stopping in front of the stop line, if it is not there, at the edge of the traffic section to be crossed. The driver must give way to the vehicles moving from the crossing road, and from the main road when there is an additional information sign 7.13. This sign can be installed before the railway crossing or the quarantine place. In such cases, the driver must stop in front of the stop line, or in front of the sign if it is not there.
- 2.6. "Advantage of opposite traffic". It is forbidden to enter the narrow part of the road in cases where it makes it difficult for oncoming traffic. The driver must give way to a vehicle that is in a narrow part of the road or is close to it.
- 2.7. "Preference to oncoming traffic". When driving on a narrow section of the road, the driver indicates that he has priority over the vehicle coming from the opposite direction. it would be appropriate to provide specific knowledge to vocational school students with the help of these rules.
